Bowlus Road Chief Reservation Terms & Conditions

Bowlus Road Chief Reservation. Thank you for placing your reservation for a Bowlus Road Chief. By making your reservation, you are securing your approximate priority for delivery of your Bowlus Road Chief:

1. A \$2,500.00 Reservation Payment will place you in the first priority queue for a Bowlus Road Chief.

Effective Date. Your **Reservation** becomes effective when (1) you place your Reservation and (2) we receive your **Reservation Payment**.

Order Process. While your Reservation secures the approximate delivery priority, it does not constitute the Vehicle Purchase Agreement or order of a Vehicle. As the start of production for your Reservation nears, you will be asked to configure your Bowlus Road Chief. Bowlus will create an order for your vehicle based on your configuration and you will receive a **Vehicle Purchase Agreement**, requiring your signature, indicating the purchase price of the vehicle, not include any applicable taxes, official and governmental fees, transport and delivery charges and any other applicable fees. We will credit your Reservation Payment towards the final purchase price of the Vehicle.

If you request to cancel your **Reservation** within 30 days of the **Reservation Date**, you will receive a full refund of your **Reservation Payment**. In order to cancel your **Reservation**, email orders@bowlus.com with your request and order number. A request for refund cannot be made via phone or in a Bowlus LLC Showroom. Your \$2,500 Reservation Payment will be credited back to the credit card on file within 10 business days. Please note all cancellations are final and you will lose your place in line once the refund has been requested.

After 30 days, or if you have entered into a **Vehicle Purchase Agreement**, your **Reservation Payment** is **non-refundable** as your order is sent to the Bowlus Road Chief factory.

You acknowledge that the Reservation Payment amount is a fair and reasonable estimate of the actual damages that we have incurred or may incur, costs that are otherwise impracticable or extremely difficult to determine. We will credit your Reservation Payment towards the final purchase price of the Road Chief. You acknowledge that this Reservation Payment and this Agreement are not made or entered into in anticipation of or pending any conditional sale contract.

When you send in your Reservation Payment you are agreeing to these Reservation Terms & Conditions.

Acknowledgements; Non-Transferable. You understand that we will not hold your Reservation Payment separately or in an escrow or trust fund or pay any interest on your Reservation Payment. Your Reservation is not transferable or assignable to another party without the prior written approval of Bowlus LLC. We may unilaterally cancel any order that we believe has been made with a view toward "flipping" of the Vehicle or that has otherwise been made in bad faith. Your deposit will be refunded in the event of a cancellation by Bowlus LLC.

Your Details. From time to time we will ask you to provide information so that we can perform our obligations under these terms and conditions.
